DSE recorded a total turnover of TZS 8.17 mln from 23,138 shares traded in 21 deals; and TZS 1.19 Billion from bond traded in 4 deals.

In the Normal Board, CRDB counter had 12,535 shares traded at weighted average price of TZS 220 per share in 6 deal(s). JATU counter had 400 shares traded at weighted average price of TZS 830 per share in 1 deal(s). NICO counter had 5,980 shares traded at weighted average price of TZS 190 per share in 2 deal(s). TCCL counter had 2,305 shares traded at weighted average price of TZS 430 per share in 4 deal(s). TPCC counter had 818 shares traded at weighted average price of TZS 2,620 per share in 4 deal(s). VODA counter had 1,100 shares traded at weighted average price of TZS 740 per share in 4 deal(s).

On the Government Bonds Board, a 20-year bond with a coupon rate of 15.49% and a face value of TZS 1.16 bln was traded at prices of 102.6800%, 104.5254%, 106.0015% and 106.4143% in 4 deal(s).
